

## Parent Agreement

### Please read and sign

I agree, on the student(s)' behalf, to abide by all policies stated in the Central Christian School Student & Parent Handbook, as they are now and as they may be revised, and I understand that those policies are incorporated into this agreement.

I authorize such discipline as seems wise and expedient for my child(ren). I agree that the administration and the Board of Trustees of Central Christian School reserve the right to dismiss any student who does not honor the standards of the school, or does not cooperate for the general welfare of the student body.

I pledge to promote a positive attitude toward Christian education, and I agree to make a good faith effort to attend parent-fellowship meetings during the school year. I agree to use the principles of Matthew 18 in resolving conflicts with parents, teachers, administrators, or board members. I understand my cooperation is requested in faithfulness in prayer, and with special gifts when possible, since tuition covers about 50% of the cost of educating a student at CCS.

I pledge to pay my financial obligation to Central Christian School in one of the following ways:

1. If I choose the monthly method of payment, I will abide by the guidelines listed on the "Monthly Tuition Payment Plan" enrollment sheet.
2. If I choose to pay annually or by semester, I will make my payments according to the following due dates. If any payments become delinquent, I will be expected to withdraw my child(ren) from CCS or to use the school's monthly tuition plan to pay off my obligation. Dates payments are due:

Annually – Tuition due in full at registration - qualifies for 5% discount.

By Semester – Tuition due at registration and on January 1; it is delinquent on Jan. 10<sup>th</sup>.

I understand that report cards will be withheld when required payments are not made in full. I understand that I am responsible for any damage my student may do to school property, as well as book fines, etc.

I give permission for my child(ren) to go on scheduled field trips and other school approved activities, and I absolve Central Christian School from liability to me or my child(ren) due to any injury to my child(ren) at school or during any school activity.

I hereby grant my consent to use and license the use of my name or my children's name or likeness whether in still or motion pictures, my photograph or my children's photograph, and/or other production, including my voice or my children's voice and features with or without my name or my children's name, for any editorial, promotional, advertising, and for other purposes.
